1. Minutes of meeting held on 16th May 2016. Approved

2. Matters arising: None

3. Duck Race 18th September 2016: DC reported that we still did not have a sponsor for the cash prize. If no sponsor is found then the cash prize will have to come out of the money from the selling of the ducks. DC will need to ask SE to start printing the duck selling leaflets next week with or without a sponsor's name. ST and SJ said they might know someone to sponsor the cash prize. DC also said she needs two other people to help her sell ducks on 16th July between 2-5 pm at The Red House Nursing Home BBQ. Also a raffle will be held at the BBQ and all proceeds will go to the Rotary Club. The Committee would like to thank Rosemarie Morton and her son for their kind generosity by supporting the duck race and the club. ST volunteered to print the duck selling sheets and deliver them to WJ so that the sponsorship forms could start to be given out to all the Rotarians from next week. MR said he would pass a board around at Tuesday lunch meetings for volunteers to sell ducks at Morrisons 23rd and 24th July and ASDA 6th August. There was discussion if there were enough members of the Club to support the duck selling at the supermarkets and sell ducks outside M&S in the High Street on 27th August and Whitefriars on 3rd September with 3 extra dates in September. DC said she would make a decision to cancel or go ahead with any extra dates after the duck selling weekends at the supermarkets. Also DC mentioned that to sell ducks on the council pitch outside M&S the council needed the collection dates and results of money collected put in a local paper and have any money collected certified by an accountant. WJ mentioned she would not be a member of the Fund Raising Committee after Tuesday. The Committee would like to thank WJ for her support.
