 - a. Finance report March 2023- updated and all in order.
 - b. Accounts. The Club accounts to June 30th 2022 are nearing completion and will be ready to upload to Charity Commission by the deadline 30/4/23.

 - c) The bulk of the meeting was taken up with discussions over the budget and subscriptions for 2023/24. Graham Bough with Jim Gascoyne and Rosemary has reviewed the Budget for the the next Rotary Year. There had also been a meeting with Martin Ward re the IT costs and how these could be reviewed and incorporated in the budget to further reduce costs (see attached paper)

GB Comments

Increasing costs for IT and MGSE and reducing accumulated balances on the RCC Club accounts, mean that, should Club Council decide to calculate membership subscriptions for 2023/24 in the same way as they were calculated for 2022/23, there would need to be a 31%

increase in the Club membership element of the subscriptions as demonstrated in the Option 1 column of the attached Budget schedule.

Two suggestions arise from my discussion with Martin:

- 1. That Dining charges from 1 July 2023 are increased by £1 to £24 and that £1 accumulated for each meal for the year will cover the Extra Digital fees of £600 for EMS support.
- 2. That the £1,200 budget for the MGSE could be met out of the RCC Millennium Trust as the aims of the two are very similar.

Should these suggestions be accepted, then the 2023/24 membership subscription could be maintained at £105 as it was for the 2022/23 year as demonstrated in the Option 2 column of the attached Budget schedule.

Should the suggestions not be accepted by Club Council, the 31% increase in the membership subscription may have a significant effect on the current and potential members. As the membership fees for the 2023/24 Presidential year will need to be announced at some stage in the near future, I assume that Club Council will consider this matter soon.

Conclusions

After discussion coupled with the IT recommendations from Martin Ward Council agreed.

- a) We should as far as possible work to a budget and subscriptions for 23/24 that is as close as possible to 22/23. To achieve this the cost of running the EMS should come from the dining club surplus rather than individual members paying extra. That is the fairest system.
- b) Council was in agreement with the paper written by Martin Ward on the IT requirements for the Club and where we could be saving money. This is turn will feed through to lowering the costs for the budget.
- c) Council was in agreement to the Millennium Trust meeting the yearly budget of £1200 from the Trust Fund as the aims are very similar. Tony to speak to Roger Power about this and then the Club as agreement will be needed from clause 1B.
