1. Matters Arising

MW advised that the estimated cost for Video Conferencing system and conference booking upgrade is £600. The booking system is now live. MW will circulate the link for the site to all committee chairs.

AL has contacted members regarding refunding dining account credits. Arrangements for repayment will be finalised by AL and ST.

2. President's Business

a) Correspondence

c) Rotary Work Club

ST has requested that this initiative is deferred until next year.

d) Water bottle refiling station

ST reported that Stage 1 approved by Viridor. Stage 2 to be submitted. Architect working on 3 quotes. Will be discussed at Centenary meeting on 26th October. Launch of fundraising campaign to follow shortly.

e) Poppy Appeal

ST advised that 9 members have volunteered to sell poppies.

f) Pentangular Presidents Meeting

The Pentangular Presidents meeting will take place in Leuven in November. ST and AL will attend the meeting in person.

g) Awards Committee

Roger Bickerton has written to the club to thank members for his Honorary membership award.

h) Co-operation with other Rotary Clubs

Successful joint event on 24th October with Canterbury Sunrise and Forest of Blean Rotary clubs to light up St Dunstan's church for world Polio day. ST arranging a meeting between AL and the Presidents and Vice-Presidents of the three Canterbury clubs to discuss further projects.

Community Service (CS)



CS primary focus will be on the following areas:

ST Nicholas School, Prince of Wales Youth Club, Rotary Youth Leadership Awards and Canterbury Food Bank.

International

a) Juba

Viv Pritchard (VP) confirmed £1k surplus can be sent to Salisbury diocese. Margaret Griffin will liaise with the school to agree best use for funds

b) Dhaka

Potential to work with Rotary Club of Dhaka. There are 2 projects of interest. One is to provide new water supplies to coastal areas of Bangladesh. The second is to provide cataract surgery for poor communities.

£700 to be transferred including donations from Julie Reza and Rosemarie Morton.

c) ShelterBox

One ShelterBox purchased in response to the Haiti Earthquake.

Vocational Service

- Senior School Writing competition for 12-18 year olds in Kent, Sussex and Essex launched. Closing date is 15th January 2022.
- b) Primary Schools Writing Competition Writing to be launched on 1St November 2021. Deadline for entries is 10th December 2021.
- Innovation Competition awards delivered to schools. Entries for new competition due by 31st March 2022

Crocuses

500 Crocus corms to be planted by 8 Primary Schools and a Local residents association. Each school received an information pack explaining the purpose Polio Plus campaign. Additional 6000 corms were distributed to Club Members. AL will report final total raised at the next Club Council meeting.
