- 1 (a) At 21 November 2023, the sum of £6,371.00 has been received from Rotarians on account of their future dining costs. At that date, some Rotarians and a guest owe a total of £420.00 for meals that they have taken but not yet paid for which leaves a net sum of £5,951.00 as repayable to Rotarians and that is accrued above. There is a deficit on the 2023/24 Dining fund of 174.35 as shown above for free meals provided to guests of the Club.
- 1 (b) The cost of the meals provided by Sodexo Prestige Ltd on 10 October 2023 and on 31 October was a total of £1,354.05 and was paid on 8 November 2023. The meal supplied by Sodexo Prestige Ltd on 7 November cost £619.65 and that supplied on 21 November cost £711.45. These are accrued above.
