Comments

- 1a At 23 August 2023, 45 members of the Rotary Club have paid their subscriptions for the 2023/24 Presidential year and 1 member has started to pay their membership by instalments, making a total of 46 paid members. The Treasurer is working to resolve issues of over and underpayment.
- 1b The Financial Budget for the 2023/24 Presidential year assumed that there would be 50 members of the Rotary Club of Canterbury paying a subscription. A reduced number of paid members may indicate the need for Council to reconsider the budgeted operating costs for the year. A shortfall of 4 members paying a subscription means that there will be a shortfall of £420 (£105 x 4) in funds available to meet budgetted costs for General Fund, IT and Pentangular costs.
- 2 The balance of £545.25 on the Centenary Dinner fund is to be retained to contribute to the costs of a celebration when 'The Water Point' is commissioned.
- 3 At 23 August 2023, subscriptions for 48 numbers in the 100 Club have been received for the year to 30 June 2024. Four prizes at £100 each have been accrued above as these sums are payable under the terms of the 100 Club rules.

- 1 (a) At 23 August 2023, the sum of £6,051.50 has been received from Rotarians on account of their future dining costs. At that date, some Rotarians owe a total of £122.00 for meals that they have taken but not yet paid for which leaves a net sum of £5,929.50 as repayable and that is accrued above. There is a deficit on the Dining account of £118.40 as shown above for free meals provided to guests of the Club.
- 1 (b) The cost of the meal provided by Sodexo Prestige Ltd on 4 July 2023 amounted to £550.80 and this was paid on 3 August. The costs of the meals provided by Sodexo Prestige Ltd on 1/8 and 8/8 totals £1,124.55 which is accrued above.
- 2 Council has agreed that the Dining General Funds are to be used to meet the costs of future speakers and their meals, and also for the costs of special events subject to the prior authorisation of the President. In accordance with the Club Council decision, the EMS support costs for 2024/25 will be invoiced at £600 by Extra Digital Ltd in May 2024 and will be charged against this fund.
